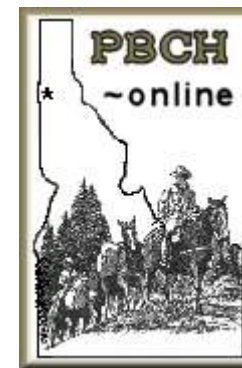

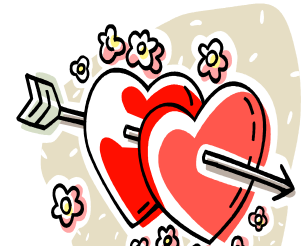
2018 Calendars are Available!!
