4TH OF JULY PASS RIDE – SATURDAY, AUG. 15

RIDE: This is a nice easy, flat and wide 10 mile loop that winds through the beautiful stands of cedar and other conifer trees, taking about 3 to 3.5 hours. First rider out at 9:30 all others out by 10 a.m. There is an outhouse on trail and a toilet at trail head, but NO water. Please bring water for your horses and a chair for yourself for an after ride hamburger lunch with dessert. Cost is \$4 per person.

PANHANDLE BACK COUNTRY HORSEMEN GENERAL MEETING – JULY 15, 2009 MINUTES

Perry Saathoff, President, opened the meeting at 7:35. We had three guests, David and Gwen Swoboda and Cindi Richardson. Minutes were approved as read. Gene Bruce gave the treasurer's report. Bills to pay - \$20 to Oreanus for web site maintenance. Lea Williams motioned to pay the bills seconded by Bea Christopherson, motion carried.

Booth at the Great Outdoor Sports Fair in Rathdrum - Perry noted that no one expresses an interest in taking this project.

Escure Ranch Work Project will be held on Sept. 26

Red Ives Work Party on July 25th -26th. Karen Kimball reported that 11 people have committed to help out. Perry Saathoff has signed the contract and we can earn up to \$1100 based on number of head of stock and mileage. We'll work on Saturday, clearing the Fly Mosquito Trail and paint the barn. FS will provide breakfast on Saturday and we'll do a potluck that night. Sunday will be a ½ day ride to the St. Joe Lodge. Wayne Parson has a paint sprayer and the Kimballs will bring a generator.

Trail Bosses are needed for the Labor Day weekend, Sept 5th – 7th for Clearwater, MT and for the Christmas Party on the Saturday, December 5th.

On the To Be Scheduled events – The Wahoo Feed Bunk project was done by the FS and as there's no interest in the Trailer Inspection, Chain Saw Certification and CPR, these events will be canceled.

Debbie Samovar made a motion that we mail in the entry forms for all the unsold 2009 calendars in the club's name since we've already paid for them. Seconded by Bea Christopherson, motion carried.

Karen Kimball reported on the July State Directors Meeting. The outdoor show will not be a state function. Twin Rivers may do something in connection with the Lewiston Chamber.

The Release of Liability Wavers are now standardized for the state and clubs. Most of our photos don't show us wearing Safety Equipment. The FS has requirements, such as chaps and hard hats. Debbie Samovar will follow up on this and get it into the newsletter and on the web site. State insurance will start on the 1st of January, so we will have to get our 2 public functions in by November. Dates can be changed on the functions, but not the functions themselves. Any additional events can be added at a cost of \$45. The BLM is reviewing their Travel Management Plan nationwide. We need to see if Bob Williams can sit in on these. Perry Saathoff will contact the BLM for more info. The 2009 State Convention will be Nov. 13th – 14th in Twin Falls. Karen has raffle tickets and there will be a silent auction. Exotic Tastes: Equine Flavor Preferences

Does your horse have a favorite flavor? Eight research horses in England did. Deborah Goodwin, BSc, PhD, research director of Applied Animal Behaviour Programmes at the University of Southampton, set out to discover what flavors horses *actually* like, compared to what horse owners and product manufacturers *think* horses like.

In Goodwin's first trial, she offered 15 flavors to eight stabled horses in a small amount of grain and measured how much they ate, how long it took them to eat it, and if any horses partially or completely rejected it. Some horses refused to eat three flavors--echinacea, nutmeg, and coriander. This left 12 flavors that were universally accepted: apple, banana, carrot, cherry, cumin, fenugreek, garlic, ginger, oregano, peppermint, and rosemary turmeric.

In the next phase of the study, the eight flavors the horses ate the fastest of the 12 offered were presented again, in all combinations of pairings, to rank the horses' overall order of preference.

The horses' top-ranked flavors were (in order): Fenugreek Banana Cherry Rosemary Cumin Carrot Peppermint Oregano

Finally, in Trial 3 she offered the horses three versions of a mineral pellet: banana-flavored, fenugreek-flavored, or unflavored. Horses ate the pellet much faster when it was flavored with either fenugreek or banana than when it had no added flavor.

The take-home: if you want your horse to eat his medication or supplements, choose products that already contain the top eight flavors horses prefer, or add them yourself.

Caution: Because there are some toxicity issues with certain sources of some of the flavors listed, make sure you are using the correct form (in some cases, an artificial flavor--for example, real cherries are toxic) in a safe dose size for your horse if adding the flavor yourself. Or, purchase pre-flavored horse-safe products to be on the safe side. Ask your veterinarian's advice before modifying your horse's diet.

I think everyone had a good time and we want to thank them all for the hard work everyone did.





I. Purpose of the Plan

This plan is to help provide an organized planning effort as well as execution of the 2009 Trail Challenge to be held Sept. 19th, 2009 at the Rider Ranch. This plan should also help provide the safest riding conditions by placing responsibilities with competent individuals, as well as informing them of their duties. The plan will be thoroughly reviewed with all volunteer workers prior to the event and distributed as needed.

II. Areas of Responsibility

III. Individuals and Duties

- A. Trail Boss - **Alan Harper** will serve as trail boss for the Trail Challenge with the Trails Committee to assist him. They will assure that trail preparation is complete and safe conditions exist on the course. An attached map outlines the course. The **Committee** will also:
1. Choose trail course and obstacles.
 2. Assure the trail is well marked prior to the event.
 3. Choose entry fee, time for event, ages of riders.
- B. Advertising _____ has primary responsibility for advertising. He/she will:
1. Print and distribute flyers to retail stores.
 2. Ensure flyers are sent to other chapters newsletters and included in our newsletter.
 3. Place advertisement in local papers, i.e. Nickelsworth.
 4. Provide a timetable for advertising.
- C. Parking - _____ has responsibility for parking. Parking should be coordinated and under the instructions of Rob and Linda Rider. He/she will;
1. Plan the parking configuration.
 2. Set up directional signs leading from the main road to the parking locations.
 3. Provide parking attendants to direct traffic flow to ensure maximum use of parking space.
 4. Clean the parking area after the event, (other members will assist)
- D. Registration - _____ are responsible for registration. Duties include:
1. Mail a map and registration conformation to pre-registers.
 2. Obtain insurance certificate.
 3. Receive rider registrations in the mail.
 4. Set up and take down the registration area.
 5. Bring \$300 in cash for change.
 6. Establish a crew for horse-holding.
 7. Provide PBCH membership information at the registration table.
 8. Provide summary of # of riders.
 9. Draw for the door prizes after registration is complete and post the results, (optional)
- E. Stations-Judges 1-10
1. To judge obstacle in course that is assigned.
 2. Have assistant to alter obstacle if needed and assist in scoring.
 3. Report to trail boss' periodically on progress of riders. Radios will be provided.
- F. Food - Rider Ranch will handle the cooking.
1. Assist if needed.
- G. Sponsor
1. Acquire donated door prizes or money (See letter on page 7. Print and take to your favorite retailer.)
 2. Maintain list of those donating.
 3. Assure those donating are recognized (letter, sign, newsletter article)
