## **Blue Creek Bay Recreation Area Update**

There are new trails in the planning stages west of the Blue Creek Bay existing trail system off Yellowstone Trail Road. PBCH members Jerry Shriner, Karen Kimball, Shari Bolander and Joni Lueck met with BLM representatives Dec. 8 to learn about the proposed trails and parking areas.

The trails will be shared among hikers, equestrians and mountain bike riders. One section of the new trail system is being planned for just mountain bikers as it is steep and winding, said Mitch Owen, recreation planner for BLM. The proposed trails for the horse folks will be in the middle of the approximate 300-acre parcel and the outside loops may accommodate the bicyclists, he said. Other plans could include a kiosk, trail maps and possibly an outhouse, he said. This Westside parcel is part of a 736-acre parcel acquired by BLM with help of the Wallace Forest family. Currently the trail system is marked with a color scheme. Forester Debbie Paul suggested the new trails could be named with help of PBCH.

PBCH did offer future help with trail marking, trail maintenance and construction of a trailhead horse gate.

## Public lands

Jerry reported a potential sizeable project at Line Creek next summer. Joni sent out information on the Pacific NW Trail and the Continental Divide Trail. In January there will be discussion of using club fees to pay for gas for members to travel to work parties.

Membership committee- no report. Diane S. asked that a spring push be made to beef up active membership. Jerry recommended starting in January. Diane suggested that we examine looking at the dues structure (when they are due) to more align to the riding season. This may be put on the January agenda for discussion.

## OLD BUSINESS

Scholarship grants- One student, Madeline Baker, has applied for the scholarship and has completed all but one of the requirements. She will work with Jim K. to repair the roof on the storage shed.

## NEW BUSINESS

Audit committee appointments- a financial review is required annually based on our by-laws. Arnie, Kay, and Carla will work on this committee. They will work with Stan to review the records at the first BOD meeting and prepare a report for the January general meeting.

Chapter T-Shirts- Karen K. is putting together an order for pullover sweatshirts, t-shirts, zip-up hooded jackets, and hooded pullovers.

Progressive Pot- Ray H. made a motion that 100% of the pot go to the person whose name is drawn if that member is present at the meeting. This would start in January, 2016. Arnie suggested that it be kept at half and the other half goes toward reimbursing people for fuel toward work parties. Diane S. made a motion to table the discussion until the January meeting. Deborah S. made a second. Karen K. shared that it has been in the past minutes that members may request reimbursement for fuel (typically \$50).

Report of the nominating committee (Joni, Stan, and Traci) & election of 2016 officers - Stan made a report. All positions were open.

Jerry accepted a nomination to run for a second year as president. There were no other nominations for president. Stan agreed to be the treasurer again. No one has agreed to serve as secretary. Dan had agreed to serve another year as VP but is now moving to Wyoming. Arnie offered to serve as VP. Kim H. made a motion to nominate him. Ray and Bob F. will serve on the BOD for another year. Deborah S. moved that they pass a unanimous vote for the slate of officers with the exception of the open secretary position. Jim K. made a second.

Les Schwab agreed to sell PBCH calendars. Karen purchased a stand to display a calendar. Ray H. will look for some at the Dollar Store. Stan made a motion to buy stands for calendars. Deb S. made second. Arnie made a motion to reimburse Karen K. for hers; Kim made a second.

PBCH \$500 Scholarship Winner Maddy Baker

**"What are the benefits of participating in the Panhandle Back Country Horsemen activities for young people such as yourself?"**

The past two years of participating in the Panhandle Back Country Horsemen have been an incredible opportunity to evaluate life in and out of the saddle. As a younger member of the Panhandle Back Country Horsemen, I was gifted with many opportunities to simply listen to insightful messages of many of our members while surrounded by God's creation.

Although the riding season was cut short by wildfires this year, I was able to join some PBCH members on the Marie Creek trail ride. Before we started out, Mr. Kimball educated me on the necessity of carrying a pocketknife at all times on the trail, explaining that it can mean the matter of life or death for a horse. I borrowed the Kimballs' mustang, Reno, who was clearly more knowledgeable than I on the trails. As we went along enjoying the views, I loved to hear the members reminisce past trail rides, which often times were accompanied by a lesson applicable to the trail. Crossing the streams gave way to a discussion on how to encourage unsure horses to cross bodies of water, and the advice I received has helped me greatly with my mare. These are just a few examples of the helpfulness and insight the members provided to me whenever I had a question.

The chilly morning warmed up within a few hours, and we tied the horses up to start on some trail work. Mr. Kimball handed me a saw, and after about thirty minutes, I had cleared out some dead vegetation that was partially blocking the trail. Doing little things like this on the trail really encourage me in knowing that I can make a difference and help people simply with some elbow grease. And, better yet, looking at the work the group did as a whole renewed my sense of togetherness and team work.

The Marie Creek trail ride is a memory I cherish, not only for the helpful advice I received, but also because it was a great chance to work and ride alongside some very insightful members.

More recently, at one of our last meetings, Miss Ginger provided a discussion on trail safety during hunting season, which is something that I had not put much thought into – thank goodness Ginger gave some valuable pointers before I rode again, or else my horse's head might be hanging above a fireplace at this very moment... One point I particularly found memorable was that not only is it a good idea to cover oneself in bright colors during hunting season, but it gives us, as horse owners, an opportunity to desensitize our horses from bright orange "scary" things, and as Ginger demonstrated, can be fashionable as well.

Overall, the two best benefits of being a young person in the Panhandle Back Country Horsemen were getting an opportunity to be outside and learning from many experienced riders. It seems that more and more people, especially my age, are choosing to spend their time inside looking at a screen. The Panhandle Back Country Horsemen have provided me with many opportunities to be outside and grow a greater appreciation for nature as well as for the mount I am riding. Listening to other members share their wisdom was greatly enriching, and not only improved my trail safety and knowledge, but helped me with much more broad topics that I will carry with me for a lifetime.
